One of the easiest and most impactful ways to make an impact at Ronald McDonald House of Delaware is to include a charitable bequest in your will or living trust. A bequest allows you to leave a legacy of support for sick children and their families without affecting your cash flow today.

With a bequest, you can give a percentage of your estate, so that your gift will remain proportional to the size of your estate, or you can give a certain amount of cash, securities or property. Either way, your gift allows you to retain full control of your assets now, while ensuring that RMHC will continue to give strength and support to families far into the future.

**HOW IT WORKS**

Individual or business estate assets are placed in a **WILL OR TRUST**. The gift is then given to **RMHC**.

**WHY SHOULD YOU CHOOSE A BEQUEST?**

A bequest to your will or living trust is:

- Easy. A few sentences in your will or living trust completes the gift.
- Flexible. Until your will or trust goes into effect, you are free to alter your plans.
- Taxable. You can designate a specific item, an amount of money, or gift contingent upon certain events or, most common, a percentage of your estate.
- Tax-free. Your estate is entitled to an unlimited estate tax charitable deduction for gifts to qualified charitable organizations such as ours.

**STEPS TO MAKING YOUR BEQUEST**

1. Determine whether you'd like to make a gift of a specific amount or leave a percentage of your estate, and whether you would like to direct your gift to a specific program or leave your gift unrestricted, allowing it to be used for our most pressing needs.
2. Take our bequest language for your estate planning attorney to include in your will or living trust.
3. Contact Ronald McDonald House of Delaware to inform us of your gift so we can thank you and ensure your bequest will be fulfilled in a manner you intend.
